# Legislation

# STORAGE TANK AND SPILL PREVENTION ACT

- Provides for the regulation of storage tanks and facilities
- Authorizes the Department to develop regulations and a permit program
- Act 32 passed on July 6, 1989
- Effective August 5, 1989

# ADMINISTRATION OF THE STORAGE TANK AND SPILL PREVENTION PROGRAM

- Title 25, Chapter 245
- Subchapters A through H
- Effective September 21, 1991

# SUBCHAPTER C. PERMITTING OF UNDERGROUND AND ABOVEGROUND STORAGE TANK SYSTEMS AND FACILITIES

- Permit regulations effective October 11, 1997
- > All USTs and ASTs must be permitted



#### **TYPES OF PERMITS**

- Two (2) types
  - Operating
  - Installation



#### **OPERATING PERMITS**

- Two (2) types of Operating Permits
  - Permit-By-Rule (PBR)
  - General Operating Permit (GOP)
- > Depends on size and substance stored
- > No fees
- Automatically renewed with proper registration
- ➤ Temporarily out-of-use tank Department withdraws operating permit



#### **OPERATING PERMITS**

- Minimal Requirements
  - Properly register each tank and, if required, pay the annual registration fee;
  - Use certified individuals for inspections and tank handling activities;
  - Meet proper technical standards;
  - Meet financial responsibility requirements; and
  - Follow proper corrective action procedures, when necessary.



#### PERMIT-BY-RULE (PBR)

- > Manufactured USTs storing petroleum
- ➤ ASTs 21,000 gallons or less that are not highly hazardous substance tanks



#### PERMIT-BY-RULE (PBR)

- Issued concurrent with proper registration using <u>Registration/Permitting of Storage Tanks Form</u>
- ➤ No permit document
- Certificate of registration lists the permit status



#### GENERAL OPERATING PERMIT (GOP)

- > ASTs greater than 21,000 gallons;
- > Highly hazardous substance tanks;
- > Hazardous substance USTs; and
- Field constructed USTs.



#### GENERAL OPERATING PERMIT (GOP)

- ➤ No permit fee
- Register tanks & apply for permit using Registration/Permitting of Storage Tanks Form
- > Certificate of registration lists the permit status



#### **INSTALLATION PERMIT**

- ➤ Site Specific Installation Permit (SSIP)
  - Construction, reconstruction or installation of new or modified storage tank
  - Permit fee depends on the capacity of the tank or tanks



#### **SSIP PERMIT**

- > AST systems with a capacity greater than 21,000 gallons
- New AST facilities with an aggregate AST capacity greater than 21,000 gallons
- Field constructed underground storage tank (UST) systems
- Storage tank systems with a capacity greater than 1,100 gallons containing a highly hazardous substance
